### Faire Rules:

1. All Merchants must exhibit and be present during the Faire, Friday November 6- Sunday November 8 9:45-5:00 pm. Set up will be November 4-5 10:00-4:00pm. **All booths must be set before 4:00 pm on November 5 as we have the King's Feast at 6:00 pm**
2. An accepted application is a commitment to participate in the Faire, and no refunds will be made for cancellations.
3. Each Merchant is responsible for collecting Florida state sales tax (7%) on sales made during the Faire. A copy of Florida State Sales Tax Certificate is **required**. Temporary Applications are available from our office.
4. There are **no animals** permitted on the Faire site.
5. All Merchants will wear appropriate Renaissance costumes, our Costume Guidelines are available on our website [www.lakerenfaire.com](http://www.lakerenfaire.com), booths must be a period shelter in keeping with the Renaissance Era.
6. Vehicle traffic in the Village will not be permitted after 9:30 am or before 5:30 pm.
7. **No smoking** by Vendor in their booth during Faire hours.
8. Camping is not allowed at site. The faire provides off duty policemen for security from 5pm-8 am

### Completed Application Package Must Include:

- All fees: Booth space, electric services, and late fees (if any).
- Business size, self-addressed, stamped envelope
- No more than 5 photos or slides or floppy disk showing merchandise and booth set up.
- Food, Games, and Ride Merchants must include proof of insurance with LCWA as additionally insured (107 N. Lake Street Tavares, FL 32778) \$1,000,000

### DEADLINES:

Applications must be postmarked no later than September 18, 2009 or a late fee of 20% is to be included. If not, we will assess fees before your booth can be set up. Incomplete packages will not be considered. Merchant will be notified of Merchant's acceptance as soon as the application has been juried in. Once a Merchant has been accepted, Merchant's check will be deposited, and acceptance is a commitment to the Faire. The deposited fees are non-refundable.

**Licenses and Permits:** Merchant hereby affirms that it now, and throughout the term of this contract, possesses and maintains all licenses and permits to perform such activities in the State of Florida, Lake County, Florida and/or the City of Tavares, Florida, including but not limited to those related the safe operation of any related equipment, the contracted activity, and the sale of merchandise.

**Indemnification:** Merchant agreed to indemnify fully and save and hold harmless Educational Foundation of Lake County, Inc. a Florida non-profit Corporation, its directors, officers, employees, and agents against all damages, claims, liabilities and causes of action of every kind and nature. Educational Foundation of Lake County, Inc. shall give Merchant prompt and reasonable notice of any claims and actions and Merchant shall have the right to investigate, compromise and defend the same to the extent of Merchant's own interest.

**Waiver of Claims:** The Educational Foundation of Lake County, Inc. and its agents shall not be held liable for and Merchant hereby releases all claims of damage to or loss of property sustained by Merchant or any person claiming

through Merchant resulting from any fire, accident, occurrence, theft, or condition in or upon the grounds/site in connection with this event.

- \*A certificate of Insurance is required of all food, games or ride Merchants. This certificate must have the Educational Foundation of Lake County and the Lake County Water Authority named as additional insured and must have minimum liability coverage of \$1,000,000 for bodily injury and property damages. The merchant must show proof that the insurance cannot be cancelled without at least a 10-day prior written notice to certificate holders. The Educational Foundation of Lake County must receive the aforementioned proof of insurance not later than 10 days prior to the Faire or a \$50 fine may be assessed. The due date for 2008 will be 10/22/09.
